

Reduced Deposits + 30 Extra Days to Pay 2026

The Reduced Deposits and 30 Extra Days to Make Final Payment Offer (the “Offer”) applies to new and individual bookings created between May 1, 2026 –May 29, 2026 (the “Offer Period”) and is available only for select sailings departing between August 1, 2026 – December 29, 2026 (the “Sailing Window” or “Range”). For the avoidance of doubt, the Sailing Window start date and end date does not indicate that a sailing will commence and conclude on those precise dates, rather, that a sailing will occur within the Range. The Offer is available within United States, Canada, and select global markets. Group bookings are not eligible for this promotion, as they are not combinable with group pricing or unnamed space. However, if an individual booking is made in FIT and later transferred into a group, the booking will retain the promotion.

The Offer provides guest(s) with the ability to book a cruise within the booking window with a reduced deposit. Guests will be expected to pay the reduced deposit within 7 days of booking creation for all markets. Amounts vary by market and stateroom, listed below:
